# MAIN AREAS OF RESPONSIBILITIES:

## **CARE PROVISION:**

- Ensure the highest possible levels of care are maintained by supporting/assisting client, when required, with washing, toileting, dressing, undressing, and all other aspects of daily living;
- Assist client in all aspects of their care needs (e.g. physical, emotional and spiritual). Provide attention when needed, whilst ensuring client retains their comfort and dignity;
- Pay particular attention to assisting client who has limited mobility, or physical difficulties, making the best and the safest use of aids provided;
- Observe care planning needs for client and complete written daily records as instructed and in line with the company's policies and procedures;
- Assist in framework of social activities by interacting with client and helping him/her continue with hobbies and activities;
- Make and change beds, ensuring that rooms are clean and tidy, and commodes are empty, in line with disposal of waste policy;
- Assist client who need help during meal times (being aware of swallowing difficulties, dietary requirements etc.). Assist with serving of food/drinks as requested/required and record them in line with client's care plan;
- Protect client form abuse and avoid abuse of the privileged relationship that exists with the client;
- Clean and maintain equipment used by client e.g. wheelchairs, hearing aids, spectacles etc.;
- Under the supervision and guidance, report on the well-being of client;
- Assist in the promotion of continence;
- Interact with client in an appropriate manner whilst always maintaining boundaries;

## **TRAINING & DEVELOPMENT**

- Maintain professional knowledge and competence;
- Attend induction and annual refreshal training days/courses, on or off site, as and when required;
- Participate in relevant trainings to achieve required qualifications;
- Be open and transparent in all situations;
- Observe and follow good practice in training sessions and advice;



# **HEALTH & SAFETY**

- Report immediately to the Line Manager and Emergency Line any illnesses;
- Understand, and ensure the implementation of Safety policy, Emergency and Fire procedure and all relevant policies and procedures which reflect care environment;
- Report to the Line Manager and/or Emergency Line any faulty appliances, damaged furniture, equipment, any potential hazard and/or risks identified;
- Contact emergency services and other professionals involved in care planning if any changes identified or any safeguarding concerns rasied;

## GENERAL

- Promote and ensure the good reputation of the company;
- Adhere to all Company policies and procedures within the defined time scales;
- Ensure that all information of confidential nature is not divulged to third parties and direct them to the Line Manager and/or Emergency Line;
- Notify the Line Manager and/or Emergency Line as soon as possible of inability to report for duty, and also on any periods of absence;
- Maintain the confidentiality of contract service terms and conditions.
